Category	Discipline	Fee
STAR 1	Singles	\$93
STAR 2-4	Singles	\$113
STAR 3	Synchronized Skating	\$150 (per team) + \$20 per skater
Introductory	Pairs	\$161 (per team)
STAR 2/3	Ice Dance	\$161 (per team)

Notes:

- All categories are subject to the availability of officials.
- There is an \$8.00 officials and technology development fee (ODF) **INCLUDED** per skater. The ODF is paid once per skater and will be discounted for skaters in multiple categories.
- Registration includes one digital action photo, per category, from Jared Reid Studios. Information on how to redeem the photo will be sent to participants following the Event.

ONLINE REGISTRATION:

Registration for all categories will take place on the Skate NL Registration website:

<https://skatenf.uplifterinc.com>. Methods of payment include: VISA, MasterCard and Discover Card. PrePaid VISA/MasterCard gift cards are also accepted.

Registration Opens: Wednesday, January 7, 2026, at NOON

Registration Deadline: Friday, January 16, 2026 *Late entries will NOT be accepted.

REFUND POLICY:

Refund requests must be made by the registration deadline. After this date, all refunds require a medical note and are subject to a \$25 administration fee. Medical notes must be submitted within 14 days of the Event.

AGE RESTRICTIONS:

Age is considered to be the age of the skater before July 1, preceding the Event.

ASSESSMENT QUALIFYING DEADLINE:

Assessment requirements must be met at the time of online registration.

SCHEDULE:

A detailed schedule will be posted on the Skate NL website as soon as possible after the registration deadline.



MUSIC:

All music must be submitted electronically with online registration. ***Please ensure correct music files are uploaded.*** Music file changes and mislabeled music files will be charged a \$25 administrative fee.

Skaters/Coaches should have a **USB** copy of music available at ice level, during the Event. CD's, phones, or other personal devices will **NOT** be accepted.

MUSIC UPLOAD INFORMATION:

- Music must be submitted for **all** categories/segments (ie: short program, free program etc.).
- Music files **must** be MP3.
- Music uploads **must** be named in the following format: **First Name Last Name - Category Program Type**
- First and Last Name **must** match the athlete's name as written on their Uplifter profile.

Category Program Type includes:

- **Category** (ie: STAR 5)
- **Discipline** (ie: Women/Girls, Men/Boys)
- **Segment** (ie: Short Program or Free Program, if applicable)
- **Age category** (ie: U10, if applicable)

Examples:

John Smith - STAR 5 Men 13&Over

Suzie Smith - PreNovice Women Short Program

COACHES ACCREDITATION:

Coaches must be a minimum of NCCP Regional Coach In-Training and be a current Professional Coaching Member of Skate Canada, in Good Standing.

MEDALS (STAR 4)

Medals shall be awarded to the top three placements in each STAR 4 category. In a category where there are less than three entries, the number of medals awarded shall equal the number of entries. **Skaters are asked to wear competition outfits and skates for all presentations.**

REPORT CARD/MEDAL PRESENTATIONS (STAR 1-3)

Presentation times will be announced at the Event. Skaters are asked to wear competition outfits and skates.

ACCIDENTS / LIABILITY:

Skate Canada, the Newfoundland and Labrador Section, and the local volunteer team undertake no responsibility for damages or injuries suffered by skaters. As a condition of and in consideration of their entries in these Championships, all competitors and their parents or guardians shall be deemed to agree to assume all risks or injuries to the competitor's person and property resulting from, or caused by or connected with, the conduct and management of the competitions and to release any and all claims they may have against the officials, the association, the Section, the Skate Canada, the volunteer team and against their officers and their entries shall be accepted only on these conditions.
